2. Filled Out Registration Form -Full Payment (2 checks -\$5.00 Jury Fee and/or Display fees)
PAYABLE TO **WAUKESHA WEST END ARTISTS**
3. New Artists -Submit Three (3) PICTURES of your work and one (1) of your display. Submit a Self Addressed Stamped Envelope to fit your Juried material (if return is requested)
4. You will receive an acceptance or denial letter. If You are NOT chosen by jury, the registration fee check will be returned.
5. If selected by jury. You will be notified 30 days or so prior to the Crawl, notifying you of your display location. Guest Artists will be placed a Downtown Waukesha location by crawl staff.
6. Display spaces are approximately 8'x8' and may vary (Set up time after 01:00p m)
 - A listing on the brochure advertising the event will highlight you as a guest artist
 - You are totally responsible for all sales and sales taxes.
 - Press releases are provided to the local media.
 - You are entitled to 25 flyers with your entrance fee (will be mailed to you)
 - **Waukesha West End Artists** are those artists CURRENTLY owning / renting gallery or studio space in the City of Waukesha.
